Resolution No. 689

Subject Matter: Coffey County Fire District No. 1

Title: **A resolution attaching certain territory located in Osage County, Kansas, to Coffey County Fire District No. 1.**

Summary: This resolution attaches described territory located in Osage County to Coffey County Fire District No. 1, effective March 1, 2001.

Resolution No. 690

Subject Matter: Coffey County Housing Authority

Subject Matter: Appointment of County Appraiser

Title: **A resolution appointing Elysa K. Lovelady, Coffey County Appraiser for a**

four year term.

Subject Matter: Appointment of County Appraiser

Title: **A resolution appointing Elysa K. Lovelady, Coffey County Appraiser for a four year term.**

Resolution No. 692

Subject Matter: Economic Development

Title: **A resolution adopting the 1999 overall economic development program of the Southeast Kansas Economic Development District, also known as the Southeast Kansas Regional Planning Commission (SEKRPC).**

Resolution No. 693

Subject Matter: County Employees

Title: **A resolution establishing the pay scale and classification for the employees of Coffey County, Kansas.**

Summary: The title is a good summary of this resolution and is effective April 1, 2001.

Resolution No. 694

Subject Matter: Technology - Internet Service Provider

Title: **A Home Rule Resolution authorizing the Board of County Commissioners, Coffey County, Kansas, to contract with Internet Service Providers for dial-up modem and/or other data communication alternatives to connect Coffey County Residents and Businesses to the Coffey County Fiber Network and the Internet.**

Summary: The title is a good summary of this resolution.

Resolution No. 695

Subject Matter: Fences

Title **A resolution establishing additional requirements for barbed wire fence deemed legal pursuant to subsection (a) of K.S.A. 29-105.**

Summary: This resolution establishes more stringent requirements than is currently required by K.S.A. 29-2105.

Resolution No. 696

Subject Matter: Township Boundaries

Title: **A resolution altering the boundaries of Burlington, Pleasant, Ottumwa and Hampden Townships in Coffey County, Kansas.**

Summary: The title is a good summary of this resolution, and becomes effective November 1, 2001.

Resolution No. 625-c (**adopted July 9, 2001**)

Subject Matter: Cash Basis Requirement

Title: **A resolution providing that the Board of County Commissioners of Coffey County, Kansas, shall cause its financial statements and financial reports of the said municipality to be prepared on the basis of cash receipts and disbursements as adjusted to show compliance with the Cash Basis and Budget Laws of this state.**

Summary: The title is a good summary of the resolution.

Resolution No. 650-B (**Adopted July 9, 2001**)

Subject Matter: County Budget

Title: **A resolution expressing the property taxation policy of the Board of Coffey County Commissioners with respect to financing the 2002 annual budget for Coffey County, Kansas.**

Summary: The title is a good summary of the resolution and sets a public hearing for August 13, 2001, at 7:00 p.m.

Resolution No. 618-t (**Adopted July 30, 2001**)

Subject Matter: Road Vacation

Title: **A resolution commencing proceedings to vacate a certain portion of the road right-of-way at the intersection of 26th Road and Oxen road and giving notice of a public hearing thereon.**

Summary: the title is an accurate summary of the resolution and setting the public hearing for August 13, 2001.

Resolution No. 697

Subject Matter: Election

Title: **A resolution prohibiting the use of stickers on ballots counted by optical scanning systems as recommended by the Coffey County Election Officer.**

Summary: A resolution prohibiting the use of stickers to cast votes for write in candidates; however, allowing hand-written votes if the voters intent can be derived from the ballot, regardless of spelling or the failure to state the full name of the write-in candidate.

Resolution No. 698

Subject Matter: Terrorism

Title: **A resolution condemning terrorism in the United States of America, and supporting the President of the United States to bring the perpetrators to justice, and recommending that the citizens of Coffey County support relief efforts by giving blood and contributing to charitable relief agencies.**

Summary: The title is a good summary of the resolution.

Resolution No. 514-a (adopted December 10, 2001)

Subject Matter: Lake Region Authority Solid Waste Management Plan

Title: **A resolution adopting the Lake Region Solid Waste Management Plan.**

Summary: The title is a good summary for the resolution.

Resolution No. 699

Subject Matter: Economic Development

Title: **A resolution authorizing the expenditure of public funds for the promotion of economic development in Coffey County, Kansas.**

Summary: The resolution authorizes the levy for and expenditure of public funds by providing monies to cities, rural water districts and public school districts in the County in order to enhance and promote economic development in Coffey County.

Resolution No. 700

Subject Matter: Rural Water Districts

Title: **A resolution establishing the Coffey County Rural Water Infrastructure Reserve Fund.**

Summary: A resolution transferring \$164,799.98 to this new fund to account for year 2001 RWD funds not yet distributed.

Resolution No. 701

Subject Matter: Year End Transfers

Title: **A resolution transferring funds to the Coffey County Capital Improvement Reserve Fund.**

Summary: A resolution transferring \$633,171.69 to the Capital Improvement Reserve fund from various sources, specifically listed on the resolution.

Resolution No.: 702

Subject Matter: Year End Transfer

Title: **A resolution transferring funds to the Coffey County Special Highway Improvement Fund.**

Summary: A resolution transferring \$436,755.00 from the Road and Bridge Fund to the Coffey County Special Highway Improvement Fund.
